**Statement Regarding Initial LCAP Development and Baseline Data**

John Muir Virtual Career Academy (JMVCA) is a newly established charter school scheduled to begin operations during the 2026–27 school year. As a result, the school does not yet have student performance, attendance, engagement, school climate, graduation, or other outcome data available for analysis. The goals, actions, services, metrics, and anticipated outcomes included in this inaugural Local Control and Accountability Plan (LCAP) are based upon the educational program, priorities, and commitments described in the approved charter petition, as well as input received from educational partners during the charter development and LCAP planning processes.

This initial LCAP is intended to establish a framework for continuous improvement by identifying key goals, actions, and measures that will guide implementation during the school's first year of operation. During the 2026–27 school year, JMVCA will establish baseline data, evaluate program effectiveness, and utilize local and state measures to inform future LCAP development and annual updates.

As student outcome data become available, future LCAPs will incorporate analysis of student achievement, engagement, school climate, and other indicators to assess progress toward goals and identify areas for improvement.

John Muir Virtual Career Academy (JMVCA) is a newly approved (Spring 2026), public, nonclassroom-based charter school authorized by the Nevada County Board of Education and operated by John Muir Charter Schools (JMCS) which is a Charter Management Organization (CMO). JMVCA serves students in grades 6–12 through a flexible independent study model that includes virtual, hybrid, and in-person learning opportunities designed to meet the needs of diverse learners throughout Nevada County and surrounding communities.

JMVCA was established to serve students who have experienced barriers to success in traditional educational settings, including students who are credit deficient, chronically absent, disengaged from school, justice-involved, homeless, foster youth, English learners, students with disabilities, and other youth in need of alternative pathways to educational success. The school also serves students participating in workforce development partnerships through organizations such as the California Conservation Corps, Certified Local Conservation Corps, YouthBuild, Workforce Innovation and Opportunity Act (WIOA) programs, and other career training initiatives.

The mission of JMVCA is to provide a flexible, nurturing, and personalized pathway for students to progress academically, earn a high school diploma, develop career skills, and achieve long-term success in college, career, and community life. The school's educational program is founded upon the belief that all students can learn and achieve when provided with rigorous academic instruction, meaningful relationships, individualized support, and access to services that address barriers to learning.

Instruction is delivered through a standards-aligned independent study program that combines online coursework, teacher-led instruction, individualized learning plans, regular student-teacher meetings, intervention services, and workforce-connected learning experiences. Students may participate in fully virtual instruction or access hybrid learning opportunities through resource centers and community-based learning environments. JMVCA emphasizes personalized learning, academic growth, social-emotional development, and career readiness through a Multi-Tiered System of Supports (MTSS) framework designed to address both academic and non-academic barriers to student success.

The school's curriculum is aligned with California State Standards and includes English language arts, mathematics, science, social science, health, physical education, life skills, career technical education, and elective coursework. High school students have access to A-G aligned courses, career pathway opportunities, industry-recognized certifications, and workforce development experiences designed to prepare them for postsecondary education, training, and employment.

JMVCA is committed to equitable access, educational opportunity, and positive student outcomes for all students. Through partnerships with families, community organizations, behavioral health providers, workforce development agencies, community colleges, and local employers, the school seeks to provide comprehensive support services that promote student engagement, persistence, graduation, and successful transitions to college and careers.

As a newly established charter school, JMVCA will use the 2026–27 school year to establish baseline performance measures for academic achievement, attendance, engagement, school climate, and graduation outcomes. The school will utilize state and local measures, including California Assessment of Student Performance and Progress (CAASPP) assessments, Renaissance STAR Reading and Mathematics assessments, graduation data, attendance data, student engagement surveys, and other local indicators to monitor progress toward LCAP goals and continuous improvement efforts.

Educational partner feedback was gathered through meetings, charter development workgroups, Board discussions, staff consultation, and review of the charter petition during the planning and development of John Muir Virtual Career Academy. Participating educational partners included the Governing Board, Nevada County Board of Education representatives during the charter review process, the Chief Executive Officer, Chief Operations Officer, Assistant Superintendent, Special Education Coordinator, Regional Directors, teachers, and members of the Parent Advisory and Student Leadership Advisory group related to LCAP for JMCS.

Educational partners consistently emphasized the need for a flexible educational model that supports students who have experienced barriers to success in traditional school settings, including credit-deficient students, opportunity youth, students participating in workforce development programs, English learners, students with disabilities, and other students requiring individualized pathways. Feedback also highlighted the importance of maintaining rigorous academic expectations while providing strong intervention supports, personalized learning opportunities, frequent student-teacher contact, career-connected learning experiences, and social-emotional supports.

As a result of this input, the adopted LCAP includes goals focused on academic achievement, student engagement, persistence, and school connectedness. Specific actions reflect educational partner priorities by emphasizing individualized instruction, academic intervention,

progress monitoring through local and state assessments, college and career readiness opportunities, attendance and re-engagement supports, family engagement, workforce development partnerships, and coordinated student support services. Educational partner feedback will continue to inform annual review and refinement of the LCAP as the school establishes baseline performance data and evaluates program effectiveness.

  - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**

- This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

## **Contributing Actions Annual Update Table**

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **8. Total Estimated Actual Percentage of Improved Services (%)**

- This amount is the total of the Estimated Actual Percentage of Improved Services column.

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**

- This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.  
  
The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
  - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
